ADVOCACY

"Speak up for those who cannot speak for themselves, for the rights of all who are destitute. Speak up and judge fairly; defend the rights of the poor and needy." Proverbs 31:8-9

Scripture emphasizes the importance of advocacy for the vulnerable, calling believers to speak up for the voiceless and defend the rights of the poor and oppressed ensuring their rights and needs are heard.

The Holy Spirit is also described as an advocate, guiding and empowering believers to live out their calling to advocate for justice and righteousness.

The concept of justice and fairness is central to biblical advocacy, urging people to uphold the rights of all, regardless of their status.



Advocacy involves the promoting the interests or causes of someone or a group of people. The main goal of advocacy is to *bring change* through public awareness or offering support.

An advocate is a person who argues for, recommends, or supports a cause of policy. Advocacy helps people to : Express their views, thoughts and concerns and to have access to information and guidance in a way that they can understand.

The 3C's of Advocacy

- 1. Collaborate Join an organized group at the federal, state or local level
- 2. Connect-Be solution-oriented
- 3. Communicate-YOUR VOICE MATTERS- remember you are a stakeholder, a voter. Contact your representatives and local leaders

- Personal connection




Our actions towards those in need reflect our relationship with and understanding of God.

How a bill becomes a law:

Introduced (with sponsors) to one of the chambers

Reviewed, assigned a number, and sent to committee (and/or subcommittee) for research/revision

How a bill becomes a law:

Voted on by full chamber

Sent to other chamber, which may accept or revise (or reject).



How a bill becomes a law:

If revised, the bill is sent back to the originating chamber for approval

After bill is agreed on by both chambers, bill is sent to President or Governor



Executive may: Sign (it becomes law) Ignore (still becomes law) Veto

If vetoed, the bill returns to legislature, which may override the veto.



How a bill becomes a law:

If, at the end of the legislative session (2 years), the bill is not passed, it dies.



If the bill does pass and becomes a law, it is handed to agencies for for administration.



Federal Budget

- Fiscal year, goes from Oct 1 to Sept 30
- Continuing Resolution using 2024 Funding Levels (mostly) until Sept.
- Congress Must Pass New Budget or Extend the Current Budget



- Governor proposes a state budget in late February for the following fiscal year, which goes from July 1 to June 30 or the following year.
- State budget must be balanced.
- State Legislature holds hearings and meets with stakeholders.
- State Legislature votes on proposed budget.



Local Government

Local Government in New Jersey consists of counties and municipalities. There are 21 counties in New Jersey and each municipality is within one of these counties. Municipalities are cities, towns, boroughs, townships and villages.

For example, I live in Jersey City, which is in Hudson County in the Greenville section of town. Greenville is a municipality within Hudson County.

Jersey City Local Government

• Office of the Mayor; City Council

City Council consists of nine members. One for each of the City's six wards, plus three at-large council

members who represent the entire City.

Board of Education (Elected)



Hudson County Board of County Commissioners

The responsibilities of County Government include areas such as the Judicial System, Law Enforcement, Education, Environment, Open Space, Job Training, Economic Development, Housing and support of our individual communities.

The Hudson County Board of County Commissioners consists of a 9 members. Each member represents a District.

Office of the County Executive

The Office of the County Executive is the administrative head of a county government, responsible for managing daily operations, implementing policies, and ensuring county services are provided efficiently and effectively.



- **Voting:** Participating in local, state, and national elections.
- **Registering Voters:** Encouraging others to participate in the electoral process.
- **Participating in Political Discussions:** Engaging in debates and discussions about public policy.
- **Organizing:** Raising awareness about issues and advocating for change.
- **Signing Petitions:** Supporting or opposing specific policies or actions.
- **Contacting Elected Officials:** Communicating with representatives to voice opinions on issues.



How to influence government officials?

What is of greatest concern to them?

Issues, plus:

Getting re-elected = Raising \$\$ → Public relations

They must demonstrate to their constituents and donors that:

- They understand
- They are responsive
- They are effective



Therefore...

to influence government officials:

- 1. Be clear about your concerns; make your case
- 2. Let them prove themselves & then show your gratitude
- 3. Let them know the consequences of <u>in</u>action

Remember: Numbers matter



3. Make a call

How to make your voice heard?

- Name & location I'm a constituent of Senator Kim's, from South Orange, zip code 07079
- Issue/topic I am concerned about...the environment, our democracy, fairness in...
- What you are asking for, e.g.,
 - The legislator's position on a bill \rightarrow ask to vote for/against a bill, the budget
 - To "co-sponsor" a bill
 - To hold a Town Hall during the upcoming recess
 - Please make a statement about...
 - To speak out more publicly, more forcefully about...
- Why this is important to you: you are a vet; you have a disabled child; you're a teacher
- Thank the staff and the Representative (Senator, Assembly member...)



5. Visit their office

How to make your voice heard?

- For a meeting:
 - Must be arranged in advance be flexible, accommodate their schedule
 - Best with a group, to get the appointment *church, diocese…*
 - Prepare key points and roles assume a 20-minute meeting:
 - Facilitator to manage the conversation
 - Others: introductions; what is the issue; how it impacts you; what is your ask; make your case; next steps
 - Ask what YOU can do to *support them* in taking the action you're requesting
 - Leave them information/materials with name(s) & contact info
 - Follow up with a Thank You note with any further info
- If you can't get a meeting: Consider a public visit / Hold a Town Hall / Protest

Using Your Economic Power

Boycotts, Divesting, Consumer activism, Moral purchasing

Boycott is an act of nonviolent, voluntary abstention from a product, person, organization, or country as an expression of protest. It is usually for moral, social, political, or environmental reasons.

Mongomery Bus Boycott, Anti-Apartheid South Africa, Grape Strike 1965

Advocacy groups are promoting boycotts of major corporations to encourage support for diversity, equity and inclusion (DEI) initiatives Amazon and Target, Walmart backlash for their perceived retreat from DEI initiatives
